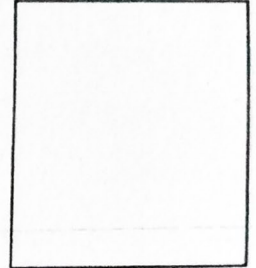

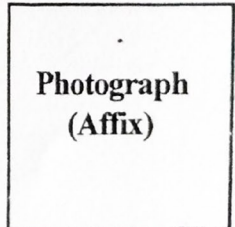

Terms & Conditions

1. He/she will not copy from the papers of any other candidate or permit his/her papers to be copied or attempt to give or attempt to obtain irregular assistance of any description.
2. The attendance sheet must be signed by the candidate whenever directed by Invig./Centre Supdt.
3. He/she will appearing in the examination under the disciplinary control of Centre Supdt/Controller of the examinations of NEHM of India, New Delhi.
4. In case of any dispute during the examination period, the decision of the controller of examination or authorised representative will be final.
5. The candidate will be required to occupy their allotted seats marked with roll number.
6. On the expiry of the time of examination, the answer copy must be handed over to the office-in-charge or invigilator performing duties in the examination hall. The candidate if found guilty or any of the following activities to have used unfair means his/her examination shall be liable to be cancelled and result will be withheld. He/she may further be debarred from appearing in the relevant examination of the Institute for a period of one year.
